GROVE CITY COUNCIL SPECIAL MEETING WEDNESDAY, JANUARY 2, 2019 2:00 PM MINUTES

The Grove City Council met in special session on Wednesday, January 2, 2019 at 2:00 PM with Mayor, Ed Trumbull presiding. Members present were Josh McElhaney, Don Nielsen, Marty Dyer and Ivan Devitt. Also present was City Manager, Bill Keefer; Attorney, Darren Cook; Assistant City Manager, Debbie Bottoroff; City Treasurer, Lisa Allred and City Clerk, Bonnie Buzzard.

PUBLIC COMMENTS:

Trumbull announced that he will open the floor to public comments first to hear facts and data from District 5 – State Representative, Josh West on his knowledge and education on the Oklahoma State Statutes pertaining to Medical Marijuana State Question 788. West expressed his appreciation to the City Council for their invitation to the meeting, and he will be glad to inform the Council, Staff and residents on this issue to the best of his knowledge. West reported that he had the opportunity to sit in on the joint interim committee that studied State Question 788 in its entirety in order to set forth and mandate the regulations and restrictions in accordance to the petition.
