C. Literature

All bids must include manufacturer's literature, information, photographs, etc. for the particular proposed item in this bid packet.

D. Warranty Information

The bidder must provide all extended warranty information regarding the particular item in this proposed bid. The bidder must also provide the name and address of the nearest service location for the proposed bid item.

E. Contract

If the bidder requires a contract in the event they are successful bidder a draft contract document must be provided.

Building:

50' x 80' x (10' wall in classroom and core/center building, 12' wall in training room)

Building code IBC 15 Double sloped roofs

Single layer VBR 3" insulation with smooth exterior surface.

Panel minimum 26 gauge Roof live load 20 or greater

Roof dead loads 2.2, collateral 1 (minimum)

Wind velocity 115 (minimum) Exposure C

16' garage doors in training room to be insulated and built for maximum entry height

All floors thru building to be clear coated/sealed

Classroom/Training Room construction requirements:

No finished exterior walls or ceiling

Classroom metal wall surfaces to be painted with commercial grade metal paint including metal conduit.

Core/Center area construction requirements:

5/8" Drywall both interior and exterior walls

1729A or equivalent 2' x 4' ceiling tile

9 solid core commercial grade wood interior

doors minimum 1.75 inches thick

Interior door frames to be 3' x 7' hollow metal

Fixtures:

Shower: 36" x 36" 1 piece fiberglass or equivalent with chrome single valve control, head and drain.

Shower dressing room: Free standing shower seat approximately 21' x 13" x 17", and 1 18" towel bar

Toilets: 16 1/2" high (minimum), ADA compliant, elongated seat and bowl, tower flush (non flapper), with slow close full seat.

Bathroom partitions: partition each ADA toilet area as well as in front of the single toilet in women's bathroom

ADA toilet areas to include 2 36" horizontal and one 18" vertical grab handle per ADA requirements.

Accessories: Each toilet to include 1 standard toilet roll holder. Each sink to include 1 paper hand towel dispenser

Bathroom sinks: ADA compliant wall mount, single hole, 20" wide or greater, with single handle chrome lavatory faucet

Bathroom above sink mirrors: minimum 21" x 30" surface mount

Kitchen sink: 18 gauge (minimum) stainless steel, 33" x 22", top mount, single bowl minimum 9" deep with basket strainer

Kitchen sink fixture: Chrome single handle pull down

Armory room utility tub: minimum 23" x 21 1/2" x 12" molded stone or stainless steel, floor mounted (w/legs), with 2 handle utility faucet with threaded end.

One 40 gallon gas water tank installed in armory room.

Kitchen cabinets:

Lower cabinets to be minimum 25.5" deep, 36" high.

Lower cabinets to be 12' long to corner transition and 13.5' long to refrigerator opening.

Include space for 33" x 22" top mount sink.

Upper cabinets to be 12" deep, 30" high, and to cover space above lower cabinets except for area over sink.

Upper cabinet to include a space for built in microwave/convection oven.

Lower cabinets to have 1 adjustable shelve, uppers to have 2 adjustable shelves.

Cabinets can be laminate or painted with commercial grade semi gloss paint.

Core material to be 3/4" industrial grade particle board or equivalent.

Cabinet door and drawer fronts can be shaker style or other standard design.

Island cabinets to be sized to allow a 1" to 2" countertop overhang.

Additional plumbing requirements:

Frost free water spigots (approx.) centered in front and rear of each long exterior wall 2 floor drains in center of training room at (approx.) the 1/3rd marks.

1 cold water faucet (approx..) the middle of long wall

Water supply to refrigerator for ice maker/water.

Countertops:

Post form laminate over 1 1/8" minimum industrial grade particle board with rounded or bullnose edge.

Countertop over wall cabinets to include standard backsplash.

Hardware:

Door hardware to be 110 degree with soft close.

Drawer slides to be soft close.

Door and drawer pulls to be metal 4" satin nickel finish wire pull.

Electrical:

Minimum 200A, 40 space indoor service panel Power to each HVAC and hot water tank

Switches and receptacles to be commercial grade 20Amp

Exposed wiring to be in enclosed steel conduit

Concealed wiring to be metal clad

GFCI in all areas as required by the 2020 code cycle

Training room: 12 high output dimmable (min 100W, 5000K) high bay LED fixtures Classroom: 12 high output dimmable (min 100W, 5000K) high bay LED fixtures

Provide a 70 amp 240 volt circuit and flexible whip for freestanding oven on kitchen wall shared with armory.

Armory: 2 at workbench level on long wall shared by kitchen,

General electrical instructions:

1 exhaust fan in each bathroom and shower Interior switch operated overhead lights over

the exterior of each man door

Weatherproof outlets on exterior near each rollup door

One 50A RV outlet on outside wall of building

Classroom and training room overhead lights operated by 2 way dimmer switches

located at the exterior entry doors to each room

Kitchen, armory, and hallway overhead lights operated by 2 way switches

located at the entry doors to each respective room

Exit signs over all 4 exterior doors and 2 interior pass thru doors

Emergency Lights: 4 in classroom, 4 in training room, 1 in armory,

1 in kitchen, 1 in men's bathroom, 1 in women's bathroom, 1 in pass

thru hallway

General instructions:

City will provide all grading.

City will provide concrete footers per the specification of building supplier

City will provide all utilities to the building including water, electrical and wastewater drainage

City will provide concrete floor.

General contractor to rough in wastewater drainage and electrical conduit for

kitchen island service under floor prior to city pouring slab.

Additional requirements for contractor:

- 1.) Performance and Payment bonds will be required.
- 2.) Builder's risk insurance will be the city's responsibility
- 3.) The project will be tax exempt
- 4.) There will be no federal funding for this project
- 5.) Permit fees will be waived by the city
- 6.) No special requirements for exterior finishes as this building will be outside city limits.
- 7.) No special requirements for HVAC. Natural gas or electric is acceptable.
