Keefer reported that he is excited about Orizon Aerostructures project, and is hoping for good things from the m Bottoroff added that as part of the incentive package to that project, the Gty of Grove has made application to the Oklaho ma Department of Commerce (ODOC) to obtain an Aerospace Certification for the Industrial Park The eligibility criteria to submit

an application is very strict. Bottoroff noted that one concern was that the Grove Airport runway is only 5,250 feet inlength, and the certification program requires the runway to be 5,500 feet inlength. Staff has advised ODOC that the Airport's Master Planincludes extending the runway to 6,000 feet inlength, and that ODOC has notified the Gity via e-mail to move forward with the application. Bottoroff added that if approved, it would benefit all of the property owners in the surrounding area.
