## STAFF REPORT:

Bottoroff reported that the Convention Tourism Bureau met and approve the purchase of a synthetic iceskating rink for the downtown Christmas season. Bottoroff reported that it is approximately a 2,000 square foot project, and that it would require a hard surface area for set-up. The Staff is proposing to set it up along Grand Street or on the employees parking lot at City Hall. Bottoroff entertained questions, comments, and concerns from the Council.

Cook reported that Director, Donnie Crain has resigned his position from the Chamber of Commerce. Cook noted that he would assume the duties of the Economic Development prospective.

Cook reported that the easement has been signed for the Civic Center, and that all the proposed tenants have signed their contract agreements. Cook reported that the sale of the Civic Center is moving forward with a tentative closing date sometimes in December.

## TRUSTEES REPORTS:

Martin asked for a status update on the Davenport project on the Wheeler Development. Cook indicated that the Wheelers are requesting an easement from the Davenports.

Lay asked for a status update on the trees along the downtown area. Bottoroff reported that the staff is visiting with a tree carver to entertain what options are available.
