Ward opened the floor for discussion and/or action with respect to consider a proposed Resolution recommending the Mayor and Council Amend Chapter 5-13: Vacation Rental Homes (VRH) by removing the requirements of submitting a Special Use Permit (SUP) application and creating Neighborhood Density Regulations for properties located in Residential Estates Zoned District (RE-1) and Single Family Residential Zoned Districts (R-1 or R-1S).

Wilhelm made a motion to approve a proposed Resolution recommending the Mayor and Council Amend Chapter 5-13: Vacation Rental Homes (VRH) by removing the requirements of submitting a Special Use Permit (SUP) application seconded by Kopp. AYE 3, NAY 1 motion carried.

Kopp made a motion to approve a proposed Resolution recommending the Mayor and Council Amend Chapter 5-13: Vacation Rental Homes (VRH) by creating Neighborhood Density Regulations for properties located in Residential Estates Zoned District (RE-1) and Single Family Residential Zoned Districts (R-1 or R-1S) seconded by Wilhelm. AYE 2, NAY 2 motion failed.
